BEAR LAKE

The Michigan DNRE in March of 2012 planted 7900 wild rose brown trout with an average length of 6.82 inches and 7900 Sturgeon River brown trout with an average length of 5.2 inches. There were no rainbow trout planted this year.

The Bear Lake Association was successful in establishing a Special Assessment District for the purpose of funding water management and invasive species control on Bear Lake. A special fee has been added to each lake property owner's winter tax bill. Treatments have taken place for milfoil and phragmites.

The Kalkaska County Sheriff's office and the Michigan DNR have reaffirmed that high speed boating hours will remain 11 A.M. – 7:30 P.M. on Bear Lake.

CUB LAKE

The BLTIA agreed to pay for an extensive study of Cub Lake to determine the lake's composition and assess the presence of invasive species. This study was completed last summer and provided many recommendations. Over the Winter, Cub Lake property owners formed the Cub Lake Property Owner's Association. Their plan is to create a Special Assessment District and implement the study's recommendations.

PROTECTING THE MANISTEE RIVER

The Bear Lake Township Improvement Association is again partnering with the Upper Manistee River Association to protect this valuable resource. Projects include erosion control structures, maintenance of in-stream structures, sediment traps, repairing riverbank damage, and portable toilet installation at key locations. Our improvement association will support the Upper Manistee River Association by providing funding for a portable toilet.

SUPPORTING OUR FIRE DEPARTMENT

The Bear Lake Township Improvement Association supported the Fire Department by recently providing bottled water and snacks for fire runs and pizza for fire department meetings.

ADOPT A HIGHWAY CLEANUP

The BLTIA volunteers to clean up trash along a two mile stretch of M-72 between Sunset Trail and Lake Valley Road. The project is coordinated by Paul Nelson along with others that clean up in April, July and September. We **welcome** volunteers!
